

Kelington Group (KGRB MK)

Another Whopping Quarter; Keep BUY

- Maintain BUY with a new MYR1.53 TP from MYR1.71, 18% upside and c.1% yield. Kelington (KGB)'s 9M22 results trumped expectations with revenue and earnings hitting quarterly records again. While the outstanding orderbook of MYR1.6bn should keep the group busy well into FY24F, we lower our target P/E on the stock to 21x (from 25x), at a slight discount to the average KLTEC P/E of 23x, to factor in the more cautious sentiment in the tech sector. Key risks are weaker-than-expected margin and orderbook replenishment.
- Another whopping quarter. 3Q22 core earnings of MYR15.7m (+16% QoQ, +97% YoY) brought 9M22 earnings to MYR37.6m (+78% YoY) ahead of our and consensus' expectations at 77% with a seasonal bump expected in 4Q. 9M22 revenue more than doubled to MYR852m due to higher contributions from all segments; EBIT margin eased to 5.5% in 3Q22 from 8.9% in 3Q21 from the higher mix of general contracting (GC) revenue. For FY23F-24F, we expect EBIT margin to recover to c.7% from the completion of the lumpy GC contract in Sarawak coupled with higher contribution from the industrial gas business.
- Segment review. Ultra-high purity (UHP) revenue increased 9% QoQ (+193% YoY) due to higher project recognitions in Malaysia, Singapore, and China and remains the largest contributor, at 56% of group revenue. The GC segment (33% of total revenue) jumped 25% QoQ on stronger revenue recognition from the Sarawak job which should be completed by 1Q23. The industrial gas segment saw revenue soaring 76% QoQ to MYR20.5m as the sale of liquid carbon dioxide (LC02) expanded to Oceania countries with plant utilisation at over 80%.
- Outlook. While the significant escalation in US trade sanctions on China's tech sector has further dimmed the sector's outlook, KGB's earnings prospects remained strong, backed by MYR1.6bn in outstanding orderbook with a record MYR1.36bn of new orders secured YTD (FY21: MYR1.2bn). The group also clinched two new contracts valued at MYR262m in the process engineering (PE) and UHP segments. KGB announced the building of a second LCO2 plant in Kerteh which would more than double existing production capacity of 50,000mt. The additional capacity is expected to come on stream by end-2023 and drive stronger recurring revenue and earnings, providing some buffer to its project-based revenues. The current plant has been operating at >80% utilisation from the ramp-up in economic activities post pandemic.
- **BUY with lower TP.** We lift FY22F-23F earnings by 7% after raising our orderbook replenishment assumptions. Our TP is now premised on lower 21x FY23F P/E or +0.5SD of historical mean which we believe is justified by the strong earnings growth into FY24F. A 0% ESG premium is bolted to our TP.


